1. The name of the Company is AMMB HOLDINGS BERHAD.
2. The registered office of the Company will be situated in Malaysia.
3. Section 21 of the Act shall apply.
The provisions as contained in the Third Schedule of the Act shall apply to the Company except in so far as the same is repeated or contained in this Constitution.
4. The liability of the Members is limited.
5. The share capital of the Company is its issued share capital. The shares in the original or any increase in capital may be divided into several classes, and there may be attached thereto respectively any preferential, deferred or other special rights, privileges, conditions or restrictions as to dividends, capital, voting or otherwise.

INTERPRETATION

6. In this Constitution the words standing in the first column of the Table next hereinafter contained shall bear the meanings set opposite to them respectively in the second column thereof, if not inconsistent with the subject or context: - Interpretation clause

“Board”	The Board of Directors for the time being of the Company.
“Central Depositories Act”	The Securities Industry (Central Depositories) Act, 1991 and any statutory modifications, rules and regulations or replacement thereof.
“Company”	AMMB Holdings Berhad.
“Constitution”	This constitution as originally framed or as altered from time to time by special resolution.
“Depositor”	A holder of a securities account.

“Depository”	Bursa Malaysia Depository Sdn Bhd (165570-W)
“Deposited Security”	A security standing to the credit of a Securities Account and includes a security in a Securities Account that is in suspense.
“Directors”	The Directors for the time being of the Company or as the case may be the directors assembled at a board meeting and also includes alternate directors or such number of them as have authority to act for the Company.
“Law”	Any applicable rule of law whether written or otherwise, including any statute, regulation, order, rule, subordinate legislation or other document enforceable under any statute, regulation, order rule or subordinate legislation. It includes the rules of any stock exchange.
"Listing Requirements"	Listing Requirements of the Stock Exchange including any amendment to the Listing Requirements that may be made from time to time.
“Market day”	Any day from Monday to Friday, both days inclusive, which is not a Stock Exchange holiday or public holiday.
“Member”	Any person for the time being holding shares in the Company and whose names appear in the Register of Members (except the Depository) including depositors whose names appear in the Record of Depositors.
“Month”	Calendar month.
“Office”	The registered office for the time being of the Company.
“Record of Depositors”	A record provided by the Depository to the Company under Chapter 24.0 of the Rules of the Depository.
“Rules”	The Rules of the Depository and any appendices thereto as may be amended or modified from time to time.
"Seal"	The Common Seal of the Company.

"Secretary"	Any person or persons appointed under this Constitution to perform the duties of the Secretary of the Company including Deputy Secretary, Assistant Secretary or any person appointed to perform the duties of Secretary temporarily.
"Securities"	Has the meaning assigned to such expression in Section 2 of the Capital Markets and Services Act 2007.
"Securities Account"	An account established by a depository for a depositor for the recording of deposit or withdrawal of securities and for dealings in such securities by the depositor.
"Stock Exchange"	Bursa Malaysia Securities Berhad or such other stock exchanges on which the Company's shares are quoted.
"Year"	Calendar year.

Expressions referring to writing shall, unless the contrary intention appears, be construed as including references to printing, lithography, photography and other modes of representing or reproducing words in a visible form.

Words importing the singular number only shall include the plural number and vice versa.

Words importing the masculine gender only shall include the feminine gender.

Words importing persons shall include corporations.

Subject as aforesaid, any words or expressions defined in the Act shall unless the context otherwise requires, bear the same meanings in this Constitution.

SHARE CAPITAL AND VARIATION OF RIGHTS

7. Subject to the Act, any preference shares may be issued on the terms that they are, or at the option of the Company are liable, to be redeemed PROVIDED ALWAYS:

Issue of
Preference
Shares

- (i) The rights attaching to shares of a class other than ordinary shares shall be expressed.
- (ii) The Company shall have the power to issue further preference capital ranking equally with, or in priority to, preference shares already issued.
- (iii) Preference shareholders shall have the same rights as ordinary shareholders as regards receiving notices, reports and audited accounts, and attending general meetings of the Company. Preference shareholders shall also have the right to vote at any meeting convened for the purpose of reducing the capital, or winding up, or sanctioning a sale of the whole of the Company's property, business and undertaking, or where the proposition to be submitted to the meeting directly affects their rights and privileges or when the dividend on the preference shares are in arrears for more than six (6) months or during the winding up of the Company.

8. Without prejudice to any special rights previously conferred on the holders of any existing shares or class of shares and subject to the Act and to the conditions, restrictions and limitations expressed in this Constitution, the Directors may allot, grant rights to subscribe for or otherwise dispose of such shares to such persons on such terms and conditions and at such times as the Directors think fit, PROVIDED ALWAYS THAT:-
- Authority of Directors to allot shares
- (i) in the case of shares offered to the public for subscription, the amount payable on application on each share shall not be less than 5% of the offer price of the share;
 - (ii) in the case of shares other than ordinary shares, no special rights shall be attached unless the same have been expressed in this Constitution;
 - (iii) subject to any conditions imposed by the Stock Exchange and/or relevant authorities, no issue of shares shall be made which have the effect of transferring a controlling interest in the Company without prior approval of the Members in general meeting;
 - (iv) every issue of shares or options to employees and/or Directors shall be approved by the Members in general meeting and in the case of issuance of shares or options to Directors:
 - (A) such approval shall specifically detail the amount of shares or options to be issued to each Director; and
 - (B) only Director holding office in an executive capacity shall participate in such an issue of shares or options.
 - (v) subject to the Act, the Central Depositories Act and/or the Rules and notwithstanding the existence of a resolution pursuant to Section 76 of the Act, the Company shall not issue any shares or convertible securities if the total number of shares or convertible securities, when aggregated with the total number of any such shares or convertible securities issued during the preceding twelve (12) months, exceeds 10% of the total number of issued shares of Company, except where the shares or convertible securities are issued with the prior approval of the Members in general meeting of the precise terms and conditions of the issue;
 - (vi) the Company shall duly observe and comply with the provisions of the Act and the Listing Requirements and/or any regulations or directives issued thereunder from time to time prescribed by the Stock Exchange applicable to any allotment of its securities.
9. Subject to and in accordance with the provisions of the Act and any rules, regulations and guidelines issued by the Stock Exchange and any other relevant authorities for the time being in force, the Company may purchase or otherwise acquire its own shares and deal with the shares so purchased in accordance with the provisions of the Act and any rules, regulations and guidelines issued by the Stock Exchange and any other relevant authorities.
- Purchase of own shares
10. The Company may pay a commission to any person in consideration of his subscribing or agreeing to subscribe, whether absolutely or conditionally, or procuring or agreeing to procure subscriptions, whether absolutely or conditionally, for any shares in the Company, PROVIDED THAT payment of the commission shall not exceed ten (10) per cent of the price at which the shares are issued, or an amount equivalent to such percentage, and that the requirements of Section 80 of

the Act shall be observed. Such commission may be satisfied by the payment of cash or the allotment of fully paid shares or partly in one way and partly in the other.

11. No person shall be recognised by the Company as holding any share upon any trust, and the Company shall not be bound by or be required in any way to recognise (even when having notice thereof) any equitable, contingent, future or partial interest in any share or any other rights in respect of any share other than an absolute right to the entirety thereof in the registered holder, except only as by this Constitution otherwise provided for or as required by the Act, the Central Depositories Act, pursuant to any order of Court or the Rules.

CERTIFICATES

12. The certificate of title to shares or debentures in the capital of the Company shall be issued under the Seal in such form as the Directors shall from time to time prescribe and shall bear the autographic or facsimile signatures of at least two (2) Directors or one (1) Director and the Secretary or one (1) other person appointed by the Directors, and shall specify the number and class of shares to which it relates and the amounts paid thereon. The facsimile signatures may be reproduced by mechanical or other means.
- Share Certificates
13. (1) Subject to the Act, the Central Depositories Act or the Rules, every Member shall be entitled to receive not later than ten (10) market days after allotment or within fifteen (15) market days after lodgement of transfer one certificate under the Seal in respect of each class of shares held by him for all his shares in that class or several certificates each for one or more of his shares in any one class upon payment of the amount of the proper duty with which each such certificate is chargeable under any law for the time being in force relating to stamps and upon further payment of the fee which the Company may be permitted by law and by the Stock Exchange to charge PROVIDED THAT in respect of a share or shares held jointly by several persons, the Company shall not be bound to issue more than one certificate in respect of any shares comprised therein and delivery of a certificate for the share or shares to one of several joint holders shall be sufficient delivery to all such holders.
- Issue of share certificates
- (2) Every Member shall be entitled to receive share certificates in such reasonable denominations as he may require for his holdings upon payment of the amount of the proper duty which each such certificate is chargeable under any law for the time being relating to stamps and upon further payment of a fee per certificate or such other sum as the Company may by law and by the Stock Exchange be permitted to charge.
- (3) The Registrar of the Company shall only issue jumbo certificates in respect of shares or securities in favour of Bursa Malaysia Depository Nominees Sdn Bhd as it may be directed by the Securities Commission.
14. Subject to the provisions of the Act, the Central Depositories Act or the Rules, if any share certificate shall be defaced, worn out, destroyed, lost or stolen, it may be renewed on such evidence being produced and a letter of indemnity (if required) being given by the shareholder, transferee, person entitled, purchaser or Member Company of the Stock Exchange or on behalf of its/their client's as the Directors of the Company shall require, and (in case of defacement or wearing out) on delivery of the old certificate and in any case on payment of such sum not exceeding

RM3.00 or such other sum as the Stock Exchange may from time to time require plus the amount of the proper stamp duty with which each such certificate is chargeable under any law for the time being in force relating to stamps and in the case of destruction, loss or theft a shareholder or person entitled to whom such renewed certificate is given shall also bear the loss and pay to the Company all expenses incidental to the investigations by the Company of the evidence of such destruction or loss as the Directors think fit.

The Company shall register the person as a shareholder of the Company in respect of the shares within sixty (60) days from receiving the aforesaid notice.

If the right to the shares is transmitted by operation of law, the person shall notify the Company in writing that the person wishes to be registered as a shareholder of the Company in respect of the shares, PROVIDED THAT where the share is a Deposited Security and the person becoming so entitled elects to have the share transferred to him, the aforesaid notice must be served by him on the Depository and that notice in writing thereof has been given to the Company. If that person elects to have another person registered he shall testify his election by executing to that person a transfer of the share. All the limitations, restrictions, and provisions of this Constitution relating to the right to transfer and the registration of transfers of shares shall be applicable to any such notice or transfer as aforesaid as if the death or bankruptcy of the Member had not occurred and the notice or transfer were a transfer signed by that Member. For the avoidance of doubt, pending the crediting of the shares into the Securities Account of such holder, such holder shall have no right to vote and attend any general meeting exercise any rights to accept a rights issue offer, receive notice or reports from the Company or deal with such shares in any manner until the Depository has credited such shares into the Securities Accounts of such holder.
- Procedure of registration
35. The registration of transmission of shares in accordance with the Act and this Constitution shall entitle the registered holder to the same dividends and other advantages and to the same rights in relation to meetings of the Company or to voting or otherwise.
- Rights of unregistered legal representatives and trustees
36. The Company shall be entitled to charge a fee not exceeding RM5.00 on the registration of every probate, letter of administration, certificate of death or marriage, power of attorney or other instrument.

FORFEITURE AND LIEN

37. The Company shall have a first and paramount lien upon all shares (not being a fully paid share) registered in the name of any Member, either alone or jointly with any other person, for his debts, liabilities and engagements whether solely or jointly with any other person, to or with the Company, whether the period for the payment fulfilment or discharge thereof shall have actually arrived or not, and such lien shall extend to all dividends from time to time declared in respect of such shares; but the Directors may at any time declare any share to be wholly or in part exempt from the provisions of this Clause.

The forfeiture of a share shall involve the extinction at the time of forfeiture of all interest in and all claims and demands against the Company in respect of the share, and all other rights and liabilities incidental to the share as between the shareholder whose share is forfeited and the Company, except only such of those rights and liabilities as are by this Constitution expressly saved, or as are by the Act given or imposed in the case of past Members. Consequences of forfeiture
48. A statutory declaration in writing by a Director or secretary that a share in the Company has been duly forfeited on a date stated in the declaration shall be conclusive evidence of the facts therein stated, against all persons claiming to be entitled to the share. The Company may receive the consideration, if any, given for a forfeited share on any sale or disposition thereof and may execute a transfer of the share in favour of the person to whom the share is sold or disposed of and he shall thereupon be registered as the holder of the share, and shall not have his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the forfeiture, sale, or disposal of the share. 49. Subject to any lien for sums not presently payable, if any, any residue of the proceeds of sale of shares which are forfeited and sold or disposed of, after the satisfaction of the unpaid calls or instalments payable at fixed times and accrued interest and expenses, shall be paid to the person entitled to the shares immediately before the forfeiture thereof or his executors, administrators or assigns or as he directs. Application of proceeds of such sale
50. The provisions of this Constitution as to forfeiture shall apply in the case of non-payment of any sum which, by the terms of issue of a share, becomes payable to the Company at a fixed date, as if the shares had been payable by virtue of a call duly made and notified. CONVERSION OF SHARES INTO STOCK

51. The Company may by special resolution convert any paid-up shares into stock and reconvert any stock into paid-up shares of any number. Conversion
52. The holders of stock may transfer the same or any part thereof in the same manner as the transfer of shares from which the stock arose may, before the conversion have been transferred or be transferred in the closest manner as the circumstances allow; but the Directors may from time to time fix the minimum amount of stock transferable and restrict or forbid the transfer of fractions of that minimum. 55. The Company may from time to time by ordinary resolution increase the share capital by such sum, to be divided into shares of such amount, as the resolution shall prescribe. Company may increase its capital
56. The Company may alter its share capital in any one or more of the following ways by passing a special resolution:- Company may alter its share capital
- (a) consolidate and divide all or any of its share capital, the proportion between the amount paid and the amount, if any, unpaid on each subdivided share shall be the same as it was in the case of the share from which the subdivided share is derived;

58. Subject to any direction to the contrary that may be given by the Company in general meeting, all new shares or other convertible securities shall, before they are issued, be offered to such persons as at the date of the offer are entitled to receive notices from the Company of general meetings in proportion, as nearly as the circumstances admit, to the amount of the existing shares or securities to which they are entitled. The offer shall be made by notice specifying the number of shares or securities offered, and limiting a time within which the offer, if not accepted, will be deemed to have been declined, and, after the expiration of that time, or on the receipt of an intimation from the person to whom the offer is made that he declines to accept the shares or securities offered, the Directors may dispose of those shares or securities in such manner as they think most beneficial to the Company. The Directors may likewise so dispose of any new shares or securities which (by reason of the ratio which the new shares or securities bear to shares or securities held by persons entitled to an offer of new shares or securities) cannot, in the opinion of the Directors, be conveniently offered under this Constitution. Issue of new shares or other securities to Members
59. The new shares shall be issued upon such terms and conditions and with such rights and privileges annexed thereto as the general meeting resolving upon the creation thereof shall direct, and if no direction be given, as the Directors shall determine, and in particular, but without prejudice to the rights attached to any preference shares that may be issued, such new shares may be issued with a preferential or qualified right to dividends, and in the distribution of the assets of the Company and with a special or restricted or without any right of voting. 60. Subject to any directions that may be given in accordance with the power contained in this Constitution, any capital raised by the creation of new shares shall be considered as part of the original share capital of the Company and shall be subject to the same provisions with reference to the payment of calls, lien, transfer, transmission, forfeiture and otherwise as if it had been part of the original share capital.

MODIFICATION OF CLASS RIGHTS

61. All or any of the rights, privileges or conditions for the time being attached or belonging to any class of shares for the time being forming part of the share capital of the Company may from time to time be modified, affected, varied, extended or surrendered in any manner with the written consent of the shareholders of such class representing not less than seventy-five (75) per centum of the total voting rights of the shareholders in such class, or with the sanction of a special resolution passed by the shareholders in such class. To any such separate meeting all the provisions of this Constitution as to general meetings of the Company shall *mutatis mutandis* apply, but so that the necessary quorum shall be Members of the class holding or representing by proxy one-third of the share capital paid or credited as paid on the issued shares of the class, and that any holder of shares of the class present in person or by proxy may demand a poll. On a poll, any holder of shares of the class in question shall be entitled to have one (1) vote for every such share of that class held by him. CORPORATIONS ACTING BY REPRESENTATIVES

92. 95. The Directors to retire in every year shall be those who have been longest in the office since their last election, but as between persons who become Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. 96. A Director appointed under Clause 114 shall be subject to rotation and retirement under Clauses 94 and 95. Directors (including Managing Director) to retire by rotation
97. A Director shall not be required to hold any share qualification in the Company until and unless the Company in general meeting shall otherwise determine. Director's qualification
98. Any Director may from time to time and at any time appoint any person to be alternate Director of the Company, PROVIDED THAT: Alternate Directors
- (a) such person is not a Director of the Company;
 - (b) such person does not act as an alternate for more than one (1) Director of the Company;
 - (c) the appointment is approved by a majority of the other members of the Board; and
 - (d) any fee paid by the Company to the alternate director shall be deducted from that Director's remuneration.
- The appointor may at any time remove the alternate Director so appointed by him from office.

An alternate Director shall be entitled to receive notices of and attend all meetings of the Directors, and to vote as a Director at any such meeting at which the Director appointing him is not present, and generally in the absence of his appointor to perform all the functions of his appointor as a Director. An alternate Director may be removed from office by a majority of the other Directors at a board meeting and shall ipso facto cease to be an alternate Director if his appointor ceases for any reason to be a Director. All appointments and removals of alternate Directors made by any Director in pursuance of the provisions of this Clause shall be in writing under the hand of the Director making the same and left at the Office.

POWERS AND DUTIES OF DIRECTORS

104. The business of the Company shall be managed by the Directors, who may pay all such expenses of and preliminary and incidental to the promotion, formation, establishment and registration of the Company as they think fit, and may exercise all such powers of the Company and do on behalf of the Company, all such acts as may be exercised and done by the Company, and as are not by the Act or by this Constitution required to be exercised or done by the Company in general meeting, subject nevertheless to any regulations of this Constitution, to the provisions of the Act, to any applicable laws and to such regulations, being not inconsistent with the aforesaid regulations or provisions as may be prescribed by the Company in general meeting; but no regulation made by the Company in general meeting shall invalidate any prior act of the Directors which would have been valid if such regulation had not been made PROVIDED ALWAYS THAT the Directors shall not without the prior approval of the Company in general meeting:-

The Directors shall duly comply with the provisions of the Act, and particularly the provisions as to registration and keeping copies of mortgages and charges, keeping of the Register of Members, keeping a Register of Directors Managers and Secretaries, entering all necessary particulars therein, and notify the Registrar of Companies of the changes therein, and lodging with the Registrar of Companies an annual return, together with the certificates and particulars required by Section 68 of the Act, as well as keeping and maintaining the documents set out in Section 47 of the Act. Directors to comply with the Act
108. The Directors shall cause proper minutes to be made of all general meetings of the Company and also of all appointments of officers, and of the proceedings of all meetings of Directors and committees, and of the attendances thereat and all business transacted at such meetings; and any such minute of any meeting, if purporting to be signed by the Chairman of such meeting, or by the Chairman of the next succeeding meeting, shall be conclusive evidence without any further proof of the facts therein stated. Directors to cause minutes to be made
109. (1) No Directors shall be disqualified by his office from holding any office or place of profit under the Company or under any other company in which the Company shall be a shareholder or which is a shareholder of the Company or a subsidiary or affiliate of such shareholder or otherwise interested or from contracting with the Company either as vendor, purchaser, or otherwise, nor shall any such contract or any contract or arrangement entered into by or on behalf of the Company in which any Director shall be in any way interested be avoided, nor shall any Director be liable to account to the Company for any profit arising from any such office or place of profit or realised by any such contract or arrangement by reason only of such Director holding that office or of the fiduciary relations thereby established but it is declared that the nature of his interests must be disclosed by him at the meeting of the Directors at which the contract or arrangement is first taken into consideration if his interest then exists, or in any other case at the first meeting of the Directors after the acquisition of his interests. If a Director becomes interested in a contract or arrangement after it is made or entered into the disclosure of his interest as required by Section 221 of the Act shall be made at the first meeting of the Directors held after he becomes so interested. Directors may contract with Company or hold office of profit or act professionally
- (2) No Director shall vote on any contract or proposed contract or arrangement in which he is directly or indirectly interested or on any matter arising thereon and if he votes, his vote shall not be counted, PROVIDED ALWAYS THAT a Director may vote on any contract or proposed contract of indemnity to himself against any loss he may suffer by reason of becoming or being surety for the Company and on any contract or proposed contract entered into or to be entered into by the Company with another company in which he is only interested by reason of (a) him being a director of the company and the shareholder not more than the number or value as is required to qualify him for the appointment as a director; or (b) him having an interest in not more than five (5) per centum of its paid-up capital.

- (3) Subject to Clause 114, a Director may with the consent of the Company in a general meeting hold any other office or place of profit under the Company (except that of auditor) in conjunction with his office of Director for such period and on such terms as to remuneration and otherwise as the Directors may determine.
- (4) A Director or his firm shall not act in any professional capacity including acting as an auditor of the Company.

- 110. A Director shall at all times exercise his powers in accordance with the Act, for a proper purpose and in good faith in the best interest of the Company. A Director shall exercise reasonable care, skill and diligence with (a) the knowledge, skill and experience which may reasonably be expected of a director having the same responsibilities; and (b) any additional knowledge, skill and experience which the Director in fact has. Duties and Responsibilities of the Director

BORROWING POWERS

- 111. The Directors may from time to time at their discretion raise or borrow such sums of money as they think proper and may secure the repayment of such sums in such manner and upon such terms and conditions in all respects as they think fit and in particular by the issue of bonds, perpetual or redeemable, debentures or debenture stock or any mortgage or guarantee, charge or security on the undertaking of the whole or any part of the property of the Company (both present and future), including its uncalled capital for the time being and borrow any money or mortgage or charge any of the Company's or the subsidiaries' undertaking, property, or any uncalled capital, or to issue debentures and other securities whether outright or as security for any debt, liability or obligation of any subsidiary, associated or other companies or persons. Power to borrow
- 112. Any debentures, debenture stock, bonds or other securities may be issued with any special privileges as to redemption, surrender, drawings, allotment of shares, attending and voting at general meeting of the Company, appointment of directors and otherwise. Terms of issue of securities
- 113. If the Directors or any of them or any other person shall become personally liable for the payment of any sum primarily due from the Company in its ordinary course of business, the Directors may execute or cause to be executed any mortgage, charge or security over or affecting the whole or any part of the assets of the Company by way of indemnity to secure the Directors or other persons so becoming liable as aforesaid from any loss in respect of such liability. Indemnity to be given

MANAGING DIRECTOR/EXECUTIVE DIRECTOR

- 114. The Directors may from time to time appoint one or more of their body to the office of Managing Director or any other executive office for such periods subject to re-appointment and at such remuneration and on such terms as they think fit; but so that no Managing Director or any Director holding any other executive office shall be vested with any powers or entrusted with any duties which the Directors themselves could not exercise or perform, and subject to the terms of any agreement entered into in any particular case, may revoke any such appointment. A Director so appointed shall be subject to retirement by rotation. Such appointment shall be automatically determined if he ceases from any cause to be a Director or if the Directors resolve that his terms of office be determined. Appointment of Managing Director

115. A Managing Director or a Director holding any other executive office shall, subject to the terms of any agreement entered into in any particular case, receive such remuneration (whether by way of salary, commission, or participation in profits, or partly in one way and partly in another but not by way of a commission on or a percentage of turnover) as the Directors may determine. Remuneration

116. A Managing Director, or a person performing the functions of a Managing Director, by whatever name called, shall be subject to the control of the Board. The Directors may entrust to and confer upon a Managing Director or any Director holding any other executive office any of the powers exercisable by them upon such terms and conditions and with such restrictions as they may think fit, and either collaterally with or to the exclusion of their own powers, and may from time to time revoke, withdraw, alter, or vary all or any of those powers. Powers of Managing Director

DISQUALIFICATION OF DIRECTORS

117. Subject as herein otherwise provided or to the terms of any subsisting agreement, the office of a Director shall be vacated: Office of Director vacated in certain cases

- (a) if he becomes of unsound mind or a person whose person or estate is liable to be dealt with in any way under the Mental Health Act 2001;
- (b) if he shall be requested to vacate office by all the other Directors, and they pass a resolution that he has been so requested and by reason thereof has vacated his office;
- (c) if he resigns his office by notice in writing to the Company at its Office;
- (d) if he has retired in accordance with the Act or this Constitution but is not re-elected;
- (e) if he is removed from office in accordance with the Act or this Constitution;
- (f) if he becomes disqualified from being a director under section 198 or 199 of the Act;
- (g) if he dies; or
- (h) if he vacates his office in accordance with this Constitution.

APPOINTMENT & REMOVAL OF DIRECTORS

118. The Company may from time to time by ordinary resolution passed at a general meeting increase or reduce the number of Directors, and may also determine in what rotation the increased or reduced number is to go out of office. At a general meeting at which more than one (1) Director is to be elected, each candidate shall be the subject of a separate motion and vote unless a motion for the appointment of two (2) or more persons as Directors by a single resolution shall have first been agreed to by the meeting without any vote being given against it. Number of Directors may be increased or reduced

119. Any vacancy occurring in the Board may be filled up by the Directors or the Members at the general meeting. Vacancy to be filled by Directors

120. The Company may by ordinary resolution of which special notice has been given, remove any Director before the expiration of his tenure of office, notwithstanding any provisions of this Constitution or of any agreement between the Company and such Director but without prejudice to any claim he may have for damages for breach of any such agreement. The Company may, by ordinary resolution appoint another Director in his stead; the person so appointed shall be subject to retirement Director may be removed by ordinary resolution

at the same time as if he had become a director on the day on which the Director in whose place he is appointed was last elected a Director.

PROCEEDINGS OF DIRECTORS

121. The Directors may meet together for the despatch of business, adjourn and otherwise regulate their meetings as they think fit. A Director may at any time, and the Secretary shall, on the requisition of a Director, summon a meeting of the Directors PROVIDED THAT notice of meeting need not be in writing. Questions arising at any meetings shall be determined by majority of votes. In the case of equality of votes, provided more than two (2) Directors present in person are competent to vote on the question at issue but not otherwise, the Chairman shall have a second or casting vote. Meeting of Directors
122. A member of the Board may participate in a meeting of the Board by means of a conference telephone or any communication equipment which allows all persons participating in the meeting to simultaneously hear each other throughout the meeting. A Director shall be deemed to be present in person at the meeting and shall be entitled to vote or be counted in a quorum accordingly. The meeting shall be deemed to take place where the largest group of those participating is assembled or, if there is no such group, where the chairman of the meeting then is. Conferencing
123. The quorum necessary for the transaction of the business of the Directors may be fixed by the Directors, and unless so fixed, shall be three. Quorum
124. The Directors may from time to time elect a Chairman and a Deputy Chairman from amongst themselves, who shall preside at meetings of the Directors and determine the period for which he is to hold office, but if no such Chairman or Deputy Chairman be elected, or if at any meeting the Chairman or Deputy Chairman is not present within five (5) minutes after the time being appointed for holding the same, the Directors present shall choose someone of their number to be Chairman of such meeting. Chairman and Deputy Chairman of the Board
125. All acts done bona fide by any meeting of Directors, or by a committee of Directors, or by any person acting as a Director, shall, notwithstanding it be afterwards discovered that there was some defect in the appointment of any such Director or person acting as aforesaid, or that they or any of them were disqualified, be as valid as if every such person had been duly appointed and was qualified to be a Director. All acts done by Directors to be valid
126. A resolution in writing signed by all the Directors present in Malaysia shall be as effective for all purposes as a resolution passed at a meeting of the Directors duly convened, held and constituted. Any such resolution may consist of several documents in like form, each signed by one (1) or more Directors. Resolution signed by Directors to be valid

COMMITTEES OF DIRECTORS

127. The Directors may delegate any of their powers to any committee consisting of such member or members of its body as the Directors think fit and any such delegation may be made subject to any conditions the Directors may impose, and either collaterally with or to the exclusion of their own powers and may be revoked or altered. Subject to any such conditions, the proceedings of a committee with two (2) or more members shall be governed by the clauses regulating the proceedings of Directors so far as they are capable of applying. Directors may delegate their powers to committees

128. A committee may elect a Chairman of its meeting. If no such Chairman is elected, or if at any meeting the Chairman is not present within five (5) minutes after the time appointed for holding the same, the members present may choose one (1) of their number to be Chairman of the meeting. Chairman of committees
129. A committee may meet and adjourn as its members think proper. Questions arising at any meeting shall be determined by a majority of votes of the members present, and in case of an equality of votes, the Chairman shall have a second or casting vote. The Chairman shall not have a casting vote where two (2) Directors form a quorum of a meeting at which only such quorum is present or at which only two (2) Directors are competent to vote on a matter in issue. Meetings of committees

SECRETARY

130. (a) The Secretary or Secretaries shall in accordance with the Act be appointed by the Directors for such term, at such remuneration, and upon such conditions as they may think fit, and any Secretary so appointed may be removed by them but without prejudice to any claim he may have for damages for breach of any contract of service between him and the Company. The Directors may from time to time by resolution appoint an Assistant or Deputy Secretary. Appointment of Secretary, Deputy or Assistant Secretary
- (b) The office of a Secretary, Deputy or Assistant Secretary shall be vacated if he resigns by giving a notice to the Directors of the Company for the time being.

AUTHENTICATION OF DOCUMENTS

131. Any Director or the Secretary or any person appointed by the Directors for the purpose shall have power to authenticate any documents affecting the constitution of the Company and any resolution passed by the Company or the Directors, and any books, records, documents and accounts relating to the business of the Company and to certify copies thereof or extracts therefrom as true copies of extracts; and where any books, records, documents or accounts are kept elsewhere than at the office, the local manager or other officer of the Company having the custody thereof shall be deemed to be a person appointed by the Directors as aforesaid. Power to authenticate documents
132. A document purporting to be a copy of a resolution of the Directors and extract from the minutes of a meeting of the Directors which is certified as such in accordance with the provisions of the last preceding Clause shall be conclusive evidence in favour of all persons dealing with the Company upon the faith thereof that such a resolution has been duly passed or as the case may be, that such extract is a true and accurate record of a duly constituted meeting of the Directors. THE SEAL

133. The Seal shall not be affixed to any instrument except by the authority of a resolution of the Board, and in the presence of any two (2) Directors or a Director and the Secretary or such other person as the Directors may appoint for the purpose and the Directors or the Director and the Secretary or other person as aforesaid shall sign every instrument to which the Seal is so affixed in their presence, and in favour of any person bona fide dealing with the Company, such signatures shall be conclusive evidence of the fact that the Seal has been properly affixed. If the Company shall be wound up, the liquidator may, with the sanction of a special resolution, divide among the Members in specie the whole or any part of the assets of the Company and any such division may be otherwise than in accordance with the existing rights of the Members, but so that if any division is resolved otherwise than in accordance with such rights the Members shall have the same right of dissent and consequential rights as if such resolution were a special resolution passed pursuant to Section 457 of the Act. A special resolution sanctioning a transfer or sale to another company duly passed pursuant to the said section may in like manner authorise the distribution of any shares or other consideration receivable by the liquidators amongst the Members otherwise than in accordance with their existing rights, and any such determination shall be binding upon all the Members subject to the right of dissent and consequential rights conferred by the said Section. Distribution of assets
159. On the voluntary liquidation of the Company, no commission or fee shall be paid to a liquidator unless it shall have been approved by shareholders. The amount of such payment shall be notified to all shareholders at least seven (7) days prior to the meeting at which it is to be considered. Liquidator's commission
160. Upon the winding up of the Company, the holders of preference shares, shall be entitled to be paid all arrears of preferential dividend up to the commencement of winding up and unless otherwise provided in this Constitution, shall not be entitled to any other further rights to participate in the profits or assets; subject as aforesaid and to the rights of any other holders of shares entitled to receive preferential payment over the equity shares, in the event of the winding up of the Company, the holders of the equity shares shall be entitled to be repaid the amount of capital paid-up or credited as paid-up on such shares and all surplus assets thereafter shall belong to the holders of the equity shares in proportion to the amount paid-up or credited as paid-up on such equity shares respectively, at the commencement of the winding up. If the assets shall be insufficient to repay the whole of the paid-up equity capital, such assets shall be distributed so that as nearly as may be the losses shall be borne by the Members holding equity shares in proportion to the capital paid-up or which ought to have been paid-up on the equity shares held by them respectively at the commencement of the winding up other than the amounts paid by them in advance of calls. SECRECY

161. Save as may be expressly provided by the Act, no Member shall be entitled to enter into or upon or inspect any premises or property of the Company nor to require discovery of any information respecting any detail of the Company's business or any matter which is or may be in the nature of a trade secret, mystery of trade or secret process which may relate to the conduct of the business of the Company and which, in the opinion of the Directors, it would be inexpedient in the interests of the Member of the Company to communicate to the public. Secrecy

INDEMNITY

162. (1) Subject to Section 288 and 289 of the Act, every Director, Secretary, auditor or other officer of the Company shall be entitled to be indemnified out of the assets of the Company against all losses or liabilities which he may sustain or incur in or about the execution of the duties of his office or otherwise in relation thereto, including defending any proceedings, whether civil or criminal in which judgment is given in his favour or in which he is acquitted or in connection with any application in which relief is granted to him under the Act by the Court in respect of any negligence, default, breach of duty or breach of trust applicable to his duty to the Company, and no Director, Secretary, auditor or other officer shall be liable for any loss, damage or misfortune which may happen to or be incurred by the Company in the execution of the duties of his office or in relation thereto. Directors and officers entitled to indemnity
- (2) No Director, Secretary or other officer of the Company shall be liable for the acts, receipts, neglects or defaults of any Director or officer or for joining in any receipt or act for conformity or for any loss or expense happening to the Company through its insufficiency or deficiency of title to any property acquired by order of the Directors for or on behalf of the Company or for the insufficiency or deficiency of any security or investment in or upon which any of the moneys of the Company shall be invested or for any loss or damage arising from the bankruptcy, insolvency or tortious act of any persons with whom any money, securities or effects shall be deposited or for any loss occasioned by any error of judgment or oversight on his part or for any other loss, damage or misfortune whatever which shall happen in the execution of the duties of his office or in relation thereto unless the same happens through his own negligence or dishonesty.

EFFECT OF THE LISTING REQUIREMENTS

163. (1) Notwithstanding anything contained in this Constitution, if the Listing Requirements prohibit an act being done, the act shall not be done. Effect of the Listing Requirements
- (2) Nothing contained in this Constitution prevents an act being done that the Listing Requirements require to be done.
- (3) If the Listing Requirements require an act to be done or not to be done, authority is given for that act to be done or not to be done (as the case may be).
- (4) If the Listing Requirements require this Constitution to contain a provision and it does not contain such a provision, this Constitution is deemed to contain that provision.
- (5) If the Listing Requirements require this Constitution not to contain a provision and it contains such a provision, this Constitution is deemed not to contain that provision.
- (6) If any provision of this Constitution is or becomes inconsistent with the Listing Requirements, this Constitution is deemed not to contain that provision to the extent of the inconsistency.
